# **Job Summary**

The Refuge Settlement Coordinator will play a key role in raising awareness of Ashiana Sheffield's specialist work in domestic violence, trafficking, and exploitation, while providing continued settlement support to clients who have moved on from refuge or direct casework. The postholder will ensure survivors remain safe, confident, and connected as they transition into independence, supporting them to access housing, employment, education, and community networks. This role combines community engagement with ongoing client support, strengthening Ashiana's impact across the region.


### **Key Tasks:**

Awareness and Community Engagement

- Promote Ashiana's domestic violence and trafficking services to statutory agencies, voluntary partners, and local communities.
- Represent Ashiana at networks, forums, and awareness events to increase visibility of our
- Support the design and dissemination of accessible awareness materials, ensuring culturally sensitive and multilingual reach.

### Client Support Settlement

- Hold a caseload of clients who have moved on from Ashiana services, supporting their transition to safe, independent living.
- Develop individual settlement plans focusing on housing stability, financial security, employment/education, and wellbeing.
- Provide one-to-one and group support sessions to build resilience, social connections, and confidence.
- Signpost and refer clients to relevant services, ensuring continued access to health, education, employment, and community-based support.









# *Integration and Empowerment*

- Co-produce activities and workshops with survivors to encourage integration and community belonging.
- Support clients to engage in volunteering, training, and peer-support opportunities that promote empowerment.
- Act as a bridge between survivors and wider community services to reduce isolation and sustain independence.

### **Training and Development**

- To be able to create and deliver training to stakeholders, community groups and facilitate group sessions and workshops.
- To provide customized training to the public sector, local authorities, NHS, Police and Higher Education Institutes.

### Monitoring and Reporting

- Maintain accurate casework records and monitoring data to evidence outcomes and impact.
- Contribute to funder reports, monitoring returns, and evaluation by capturing outcomes and success stories.
- Support fundraising bids by providing evidence of the effectiveness of post-service settlement support.
